

Consulting Abroad

- Consulting abroad is doing business outside the USA
 - Visiting prospective clients
 - Consulting directly with clients overseas
 - Collaborating with overseas consultants
 - Teaching courses
 - Managing your business
 - Gaining a different cultural perspective

Initial Steps – Clients and Projects

- Know your client/customer
 - How was the contact made?
 - Direct contact through friends
 - Direct contact through the internet (your website, LinkedIn)
 - Through another organization (CECON, YourEncore)
- Who are your principle contacts?
- What are the goals of your trip?
- How will you be paid?
 - Check if your client's country has a tax treaty with the US: <u>https://www.irs.gov/individuals/international-taxpayers/tax-treaties</u>
 - IRS form 8802 and 6166 are used to claim income tax treaty benefits. <u>https://www.irs.gov/individuals/international-taxpayers/form-8802-application-for-united-states-residency-certification-additional-certification-requests</u>

Initial Steps – Overseas Countries

- Read about the countries you plan to visit for business
 - VISA requirements
 - Do you have a valid passport?
 - Some countries refuse entry if passport expires in less than three or six months
 - Business practices and customs
 - <u>Travel Warnings</u> on travel.state.gov
 - Check the requirements of the countries you plan to visit

Initial Steps – US Law

- Review the <u>Bureau of Industry and Security</u> (BIS) and <u>Office of</u> <u>Foreign Assets Control</u> (OFAC) websites
- "Bad guy lists" make sure your client and their company is not on any list
- Make sure that you or your company do no work for an embargoed country

Bureau of Industry and Security (BIS)

- Review the BIS Ten General Prohibitions
 - (1-3 goods related, 4-10 apply to everything)
- Review the BIS <u>"Know Your Customer Guidance"</u>
 - End use, end user don't self blind
- Review BIS <u>"Red Flags"</u>
- Review the BIS Consolidated Screening list
- Review the lists of Parties of Concern
 - People
 - Companies
 - Banks
 - Any other parties to the transaction

Office of Foreign Assets Control (OFAC)

- OFAC Sanctions list
- Searchable list of Blocked Persons ("SDN List")
- Review the companies and persons who you will consult with to make sure they are not blocked



Sanctions List Search

This Sanctions List Search application ("Sanctions List Search") is designed to facilitate the use of the Specially Designated Nationals and Blocked Persons ist ("SDN List") and all other sanctions lists administered by GPAC, including the Foreign Sanctions Evaders List. The List of Persons Istent(Face Sole) Pursuant to E.O. 1399, the Non-SDN Iran Sanctions Act List. the Part 561 list administered by GPAC, including the Foreign Sanctions Evaders List. Planning Travel

- Who will arrange travel, hotel and transportation?
 - Will you be picked up from the airport make sure transportation is secure if necessary
- Will your phone work in the foreign country?
 - Purchase call plan prior to leaving
 - Client may provide a local SIM card
 - Use Internet-based apps like WhatsApp or Skype to lower cost
- Are there any foreign holidays that could impact your trip or work?
- Review best business practices in that country

Planning Travel

- Do you need any travel shots or medicine?
 - Check the CDC website for information on the countries you plan to visit
 - Schedule a doctor's visit to get any shots or medicine if needed
 - Read about the medical care in the countries you plan to visit
 - Think about purchasing travel insurance

Other Steps Before You Fly

- Notify credit card companies about which countries you plan to use their card
- Bring your ATM card or cash
- E-mail photocopies of you passport, VISA's and flight itinerary to yourself
- Enroll in the Smart Traveler Program if needed to provide emergency contacts get updates about your destinations

Completing Work

- Review with the client whether objectives were met
- Review or schedule any follow up consulting
